CHIANG MAI UNIVERSITY and YAMAGATA UNIVERSITY hereby conclude this agreement to promote the development and friendship between the two universities via international cooperation in education and research.

- 1. CHIANG MAI UNIVERSITY and YAMAGATA UNIVERSITY will use their best efforts to promote mutual understanding and friendship between the two universities through:
  - (1) Exchange of the faculty and staff
  - (2) Exchange of students
  - (3) Promotion of joint research projects
  - (4) Exchange of research reports, publications and academic information
  - (5) Other activities by mutual agreement
- 2. CHIANG MAI UNIVERSITY and YAMAGATA UNIVERSITY shall collaborate to prepare a detailed program when executing each of the above activities
- 3. This MOU will be in effect from the date of its signing for a period of five years. The agreement may be automatically renewed every five years, unless either University wishes to terminate the agreement. Such termination by one institution shall be effected by giving the other institution at least ninety days advance written notice of its intention to terminate.
- 4. This agreement is executed in duplicate in English, with both texts being equally authentic.

# AGREEMENT ON STUDENT EXCHANGE BETWEEN CHIANG MAI UNIVERSITY AND YAMAGATA UNIVERSITY

CHIANG MAI UIVERSITY and YAMAGATA UNIVERSITY shall verify the following clauses in connection with implementation of exchange students program based on the bilateral cooperation agreement.

- 1. Each university may send and accept at most two students each year. The duration of stay for the students at either host university shall be from six months to one year.
- 2. Each university, conforming to the admission requirements of the host university, shall assume full responsibility in the assessment and selection of qualified candidates.
- 3. All exchange students shall be subject to the same academic regulations regarding class performance as pertain to regularly enrolled students at the host university.
- 4. The host university shall exempt the students exchanged from paying entrance examination, admission and tuition fees.
- 5. Students exchanged will be responsible for all other expense, including their own transportation to and from the host university, all room and board related costs, living expense, health insurance, and other costs. All medical expense not covered by the insurance plan are the sole responsibility of each student.
- 6. Violation of local laws committed in the host country could subject the exchange student to immediate withdrawal of his/her exchange sponsorship. The student could be sent home.
- 7. It is the sole responsibility of the home university to decide how many credit could be student may actually receive on courses taken at the host university.

- 8. This agreement shall take effect when both university representatives have signed it and will continue for five years. The agreement may be automatically renewed every five years, unless either party wishes to terminate the agreement.
- 9. This agreement is executed in duplicate in English, with both texts being equally authentic.
